- This Price List is designed to provide clients with a detailed overview of the Charges related to Application Services fees and will be effective from 1st March 2025.
- By means of this Price List, new (Application) Services are offered and certain corrections are made. This updated version is not to be regarded as an update as referred to in article 5.2 of the GTCs and Euronext reserves the right to update this Price List to that effect at a later stage in 2025.

1. GENERAL PRINCIPLES

- Application Services fees relate to Charges for the network configuration and management of unicast and multicast services.
- Clients should review the documentation covering the Connectivity Services offering to ensure the necessary requirements are understood.
- Clients are charged for Application Service fees based on the services to which they subscribe.
- Application Services fees are applied to Members via WAN, Service Providers via WAN and Services Providers via Service Providers.
- Fees for Market Data Application Services (multicast and unicast) are per service and per Port, in the case of CMC Services, or per service and per circuit, in the case of EMC Services. In the case of a Service Provider behind a Service Provider, Market Data Application Services fees are applicable per Client Site.
- Trading/Drop Copy Application Services (unicast) fees are per Client Site.
- Clearing Application Services (unicast) fees are per Client Site and based on the role of the End User with regards to Clearing Services (General Clearing Member, Individual Clearing Member and Non Clearing Member).
- In the case that Clients are connected to the DR Data Centre, no Application Service fees are due on that Access Port/circuit.
- Billing will be automatic, regardless of whether the Connectivity Services are used by the Client or not. Full payment is due for every calendar month.
- Euronext may at its sole discretion allow its Clients to subscribe on a non-discriminatory basis to temporary validation tests or comparable undertakings regarding new or ancillary Connectivity Services, which may give rise to different Charges as set forth herein.
- Detailed Connectivity Pricing is described in this Price List.
- Prices are indicated in EUR and are excluding any applicable Taxes (including VAT).

2. APPLICATION SERVICES FEES FOR MEMBER

A "**Member**" is an entity that has been approved as such by Euronext under the Rules and is authorised to access the matching engine subject to its own risk management processes. Any entity that trades via a broker or a clearing firm will, for pricing purposes only, be considered a "Member" hereunder.

It is understood that for Members receiving MDG Lite (unicast and/or multicast) only, the fees for up to 100 Mbps bandwidth are applicable, as described in section 2.1 below, "Market Data Application Services fees for Members".

An "ISV (Independent Software Vendor)" is an entity that has been approved as such by Euronext under the Rules. ISVs are authorised to access the EUA environment for development purposes only. As a consequence, no ASFs are due for Clients qualifying (only) as an ISV.

It is understood that Cash or Derivatives Market Data Application Services Fees are applicable also to Service Providers receiving MDG Lite only (unicast and/or multicast).
