1. COLOCATION PRICING: GENERAL PRINCIPLES

- The Colocation Services pricing model applies to all Colocation Services provided at the Aruba Data Centre.
- Colocation Services are fully operated by Euronext. Order forms and contracts governing the provision of these new services must be signed with Euronext.
- Euronext Colocation Services are available to Members and Non-Members.
- Different prices are applied to Members and Non-Members and are indicated in euros (€).
- Application Services fees relate to prices for multicast services in colocation.
- Application Services fees are charged per service and per FTEx.
- Participant Access fees are charged per service on a per End User basis. A client of a Service
 Provider is considered an End User when the Client receives raw Euronext Data.
- Colocation Services are invoiced by Euronext directly to Members and Non-Members. Billing
 is automatic, regardless of whether or not the Colocation Services have been used by the
 Client. Full payment is due for every calendar month.
- Euronext may at its sole discretion allow its clients to subscribe on a non-discriminatory basis to temporary validation tests or comparable undertakings regarding new or ancillary Colocation Services, which may give rise to different Charges as set forth herein.
- Charges set out herein that are not amended by means of this updated Price List may be amended by Euronext at a later stage in 2026.
- For the avoidance of any doubt, Euronext is entitled to further update the Price List during this calendar year when it introduces new Services.
- Detailed Colocation pricing is described in this Price List.
- Charges for Services requested by a Client and not explicitly specified herein shall (to the extent acceptable to Euronext, to be determined at Euronext's sole discretion) be quoted separately by Euronext and apply accordingly to such Services once the quote is accepted by the Client.

2. EURONEXT COLOCATION PRICE LIST

A. Hosting Colocation Services

This document provides an overview of the pricing for Euronext Colocation Services.

Euronext offers a range of Colocation Services to Euronext Members and Non-Members. Specific conditions and pricing may be applied. Please refer to the Colocation Agreement Order Form or Change Request.

Members/Non-Members:

- A "Member" is any entity that is classed as a member, as defined in the General Terms and Conditions (GTCs)
 - Note that an entity that trades via a broker or a clearing firm will be considered as a "Member" for pricing purposes only.
- A "Non-Member" is any entity that is not a Member, but which is a party to an Other Euronext Agreement:
 - A Service Provider Agreement:
 - Application Service Provider (ASP)
 - Extranet Service Provider (ESP)
 - A Data Licence.

The table below indicates what type of Charges apply to a given Client depending on that Client's specific status and that of any Affiliates or End Users the Client may be authorised to service under the Agreement. Euronext's qualification of a Client shall be binding upon the Client.

Colocation cabinets and hosted users

There are three (3) cabinet options available in the Colocation area: **4kW, 9kW or 18kW of peak power**.

Each cabinet is provided with a power distribution unit (PDU) by default.

Pricing for Non-recurring Fees is the same for Member and Non-Member.

Note 1: 18kW cabinets are not available to Non-Members.

Note 2: For PNU, Clients can uniquely reserve a 4 kW Cabinet. Cabinets can be reserved on a PNU basis in the Colocation Room only, not in the MMR or within the Roof Room. Clients can reserve cabinets on a PNU basis for up to a maximum of 25% of the total number of their Cabinets in the Colocation Room (the number of cabinets will be rounded down). For example (for illustration purposes only), if a Client has ordered 10 Cabinets, it can reserve a maximum of two Cabinets on a PNU basis. Clients with less than four Cabinets in the Colocation Room will however be permitted to reserve one Cabinet on a PNU basis. The power activation of a PNU will not give rise to additional one-off fees.

Note 3: The P&C Unit will vary every month on the basis of the actual power and cooling cost incurred by Euronext. The variable costs for energy and cooling (calculated by applying a 75% usage rate on the P&C Unit) are distinguished from the other applicable fixed Charges per Cabinet size as reflected in the Price List.

Note 4: The hosted user fee only applies to Service Providers, being Non-Members providing hosting services to End Users in their Cabinet(s) located in the Colocation Room. An additional fee per Hosted End User is applied in this case irrespective of the Markets the Hosted End User is accessing (including MTS).

Note 5: One-off fees will be invoiced upon the installation of the service.

B. Colocation Services

Cabinet Management

In the event that the Client requests Euronext to provide support to establish a structured cabling solution (as to be determined by Euronext) and such request is acceptable for Euronext, Euronext shall issue a specific quote in respect thereof to the Client and, if accepted by the Client, Parties will conclude a specific statement of work (in a format determined by Euronext) to document such non-standard Services.

Warehouse Services

Clients will be able to request dedicated lockable shelf compartments (individually enclosed) for the storage of spare parts and materials.

3. EURONEXT CROSS-CONNECTIONS WITHIN THE COLOCATION PRICE LIST

A. Colocation Room to Euronext's Optiq® Matching Engine

Multiple single-mode optic fibre links are needed by Clients to connect their equipment to Euronext's Optiq® matching engine ("**Optiq Matching Engine**"). These links are used either for unicast or multicast traffic.

Connectivity between the Client's cabinet and the Optiq Matching Engine is provided by:

- 1. Multicast FTEx: a pair of single-mode fibre links for multicast A & B feeds
- 2. Unicast FTEx: a pair of single-mode fibre links for TCP/IP connection (Order Entry Gateway, Drop Copy) with full resiliency

Please note that, as per RTS 10 requirements, Euronext will arrange for the same cable length for all Clients when required by Applicable Law.
