Decommissioning of Euronext File Services (EFS) and End of Day (EOD) and migration to CFTS

Summary

Euronext File Services (EFS) and End Of Day (EOD) will be decommissioned by **30 October 2023**. The services offered through EFS and EOD are already available via the new Common File Transfer System (CFTS) of Euronext. **Clients that do not have access to CFTS are advised to request access and migrate as soon as possible**, while clients with access to CFTS should ensure all their applications are migrated to retrieve the files via CFTS.

EFS and EOD decommissioning

Euronext will decommission the services offered through the Euronext File Services (EFS) and End Of Day (EOD) by **30 October 2023**.

Please see below the timeline with the dates of decommissioning for each of the services.

The services provided via EFS and EOD are already available via Euronext's new file transfer system: Common File Transfer System (CFTS), live since December 2022.

Euronext has gradually introduced the following services on CFTS:

- Referential files i.e. Standing Data Files;
- EOD Services;
- Reconciliation files.

Clients' migration to CFTS

Depending on their current set-up, clients must take the following actions:

- Clients who only have access to EFS and/or EOD **must migrate to CFTS before 30 October 2023.**
- Clients who have access to both EFS/EOD and CFTS **do not need to take further action.** Euronext will decommission the EFS and EOD services.
- Clients who only have access to CFTS do not need to take any action, as they are not impacted by the change of this service.

Clients who do not have access to CFTS yet must request it via MyEuronext, the new Euronext customer portal. They must therefore be onboarded onto MyEuronext by signing

the MyEuronext Terms & Conditions. For further information or support, clients are invited to liaise with the [Optiq Migration Team](#).

CFTS protocols and support API

As a reminder, CFTS is accessible through two protocols:

- SFTP: dedicated secured file transfer protocol optimised for massive upload and download
- HTTPS: web-oriented platform with a GUI, in MyEuronext

These two solutions have already been delivered. Euronext will also make it possible to reach the CFTS services via a CURL / REST API as of July 2023, however clients should note that these services will be provided by Euronext with reduced support and that clients are strongly encouraged to use the SFTP and HTTPS CFTS services instead. Furthermore, clients have the possibility to automate file transfer via the SFTP protocol instead of a CURL / REST API.
