Euronext informs clients that a **Disaster Recovery test** for Cash and Derivatives markets will take place on **Saturday 5 October 2024**, in line with the FIA Disaster Recovery Exercise.

The test will be an important opportunity for clients to test the Business Continuity event, when Exchange switches from the production environment to its secondary site (DR environment), which provides redundant standby systems to be used upon the failure of the Exchange Production environment.

A business continuity event occurring on the Exchange's trading system will encompass a whole market, including all the segments and partitions. That means that both Cash and Derivatives Euronext markets will be in scope for this test.

Further details and guidelines on the Disaster Recovery test will be provided in due course.
