The Euronext Corporate Actions Portal offers two different levels of subscription to users: the Standard and the Premium.

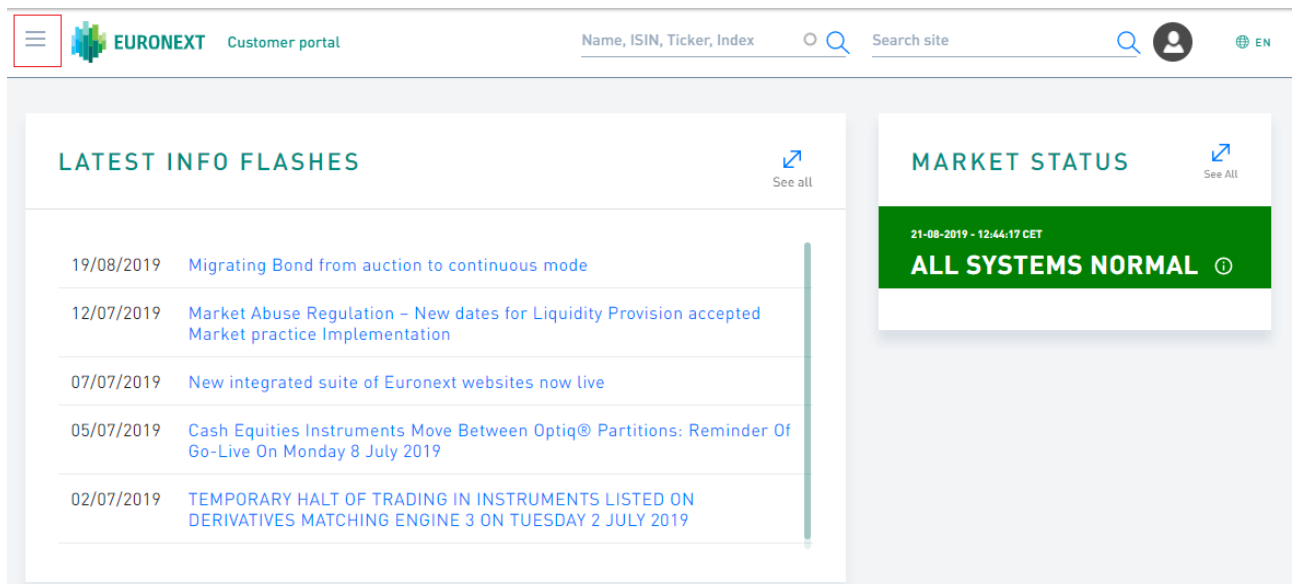

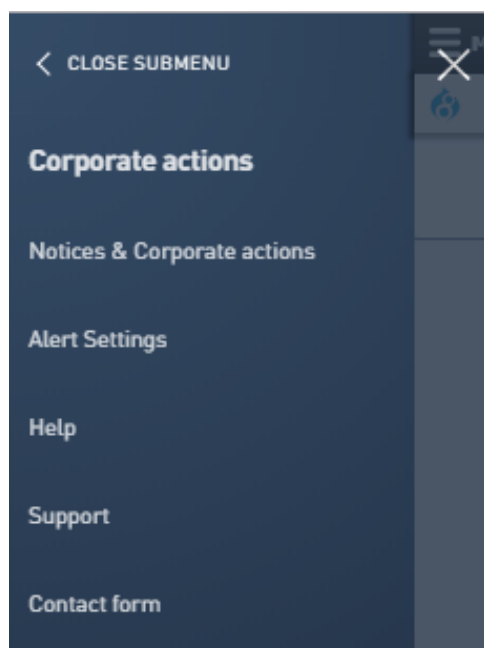
The user may press “Corporate Actions” to access the “Notices and Corporate Actions” page, which is where all the licensed content is available to be accessed.

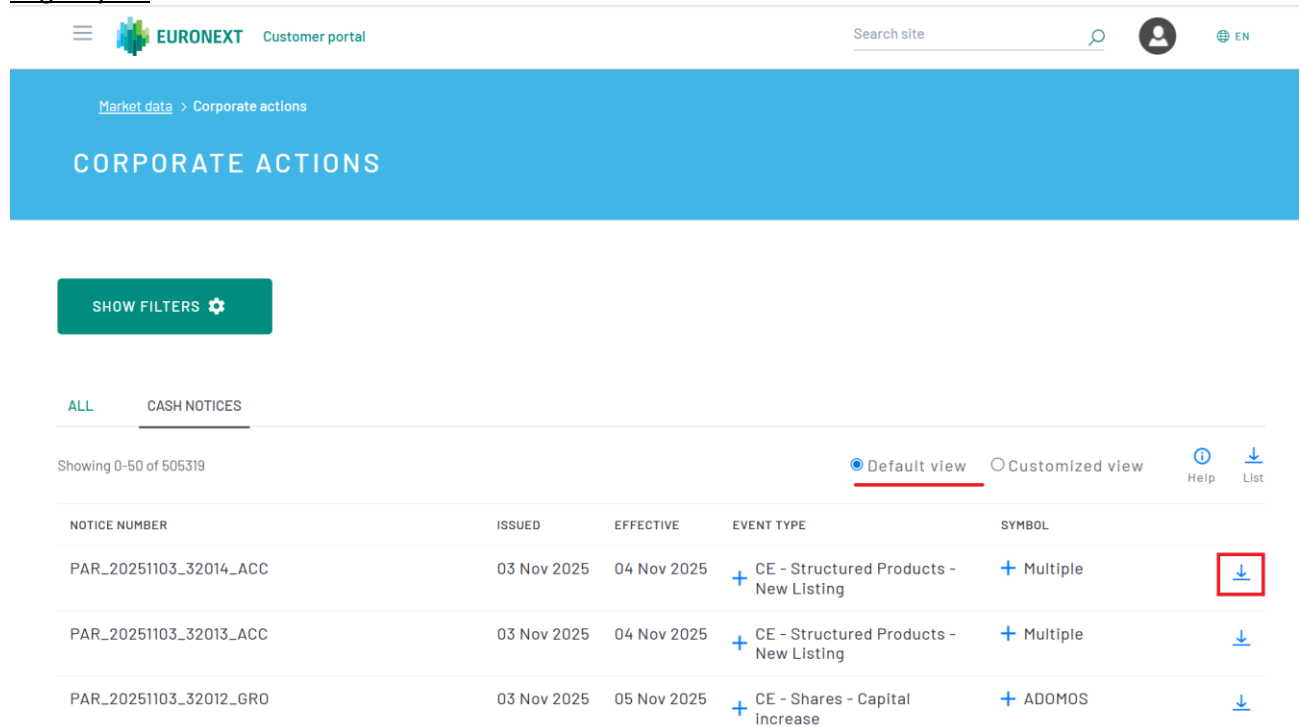
3.6 NOTICES & CORPORATE ACTIONS PAGE **(UPDATED 06 NOV 2025)**
