### 3.1 FORMAT

- All files are in CSV format. The delimiter is a semicolon, so this character is never used in the fields.
- All dates have the same format: DD/MM/YYYY (DD = day, MM = month, YYYY = year).
- All numerical values follow standard international practice (decimal separator is a point).

#### 3.2 FILE AVAILABILITY

There is no fixed availability time for the NextHistory Market Concentration HHI files. The files are made available on the SFTP server as soon as they are ready and the availability of the files varies per day depending on previous day's trading activity.


