EURONEXT POWER DERIVATIVES INTRODUCTION EFFECTIVE 1 JUNE 2025

Euronext and Nord Pool are pleased to announce the launch of a new European Power Futures Market, dedicated to Nordic and Baltic Power Derivatives. These Power Derivatives will be listed on the Euronext Amsterdam Derivatives market. The Market Data generated by the new Euronext Power Futures Market will be integrated into the Euronext Market Data Agreement (EMDA) and the Euronext Datafeed Subscriber Agreement (EDSA), expanding Euronext's harmonised commercial model to a new market.

MARKET DATA CHANGES

The Market Data generated by the new Euronext Power Futures Market will be licensable under the EMDA and EDSA, as a standalone Information Product called Euronext Power Derivatives, which will be fee waived until the end of 2025. The contract documentation has been updated to reflect this change.

TECHNICAL MIGRATION TO OPTIQ® MARKET DATA GATEWAY

Market Data for Euronext Power Derivatives will be available on the Optiq® Market Data Gateway (MDG) via a dedicated MDG channel i.e. MDG Channel ID 38 – Power Derivatives.
