1. INTRODUCTION TO THE REPORTING REQUIREMENT

The EMDA Reporting Policy, which forms part of the EMDA, sets out the Contracting Party's reporting obligation for

- its internal distribution and display use of real-time market data.
- its redistribution of market data to its subscribers that have been approved for natural user.
- its redistribution of market data as part of managed non-display use services.
- its redistribution of market data as part of an ASP Service or ESP Service to trading members.
- its redistribution of market data to non-professional subscribers.
- its redistribution of market data as part of White Label Services.
- its redistribution of market data to its subscribers and/or sub vendors

The table below provide an overview of your reporting and declaration obligations as a Contracting Party.

MONTHLY REPORTS – EMDA Reporting Policy	
WHAT	A monthly electronic report, indicating <ul style="list-style-type: none"> ▪ the Customer's access to real-time market data for display purposes; and ▪ its subscriber's (employees) ability to access real-time market data for display purposes
WHEN	Customers who are not Redistributors: Each month, within 14 days of the end of each calendar month. ----- Redistributors: Each month, within 30 days of the end of each calendar month. ----- Direct Reporting Customers: Each month, within 14 days of the end of each calendar month.
FREQUENCY	Monthly
REPORTABLE UNIT/UNIT OF COUNT	Each User per Source with the ability to access real-time market data, where 'User' refers to a natural person and 'Source' refers to each separate data feed product from an Information Supplier or, in case of a direct connection, Euronext. Each Device with the ability to access real-time market data where a device cannot be allocated to a natural person. (Note, simultaneous access on such Device is not permitted).
FEES	Monthly fees are applicable to each reportable unit with the ability to access real-time market data. The applicable fees are outlined in the Information Product Fee Schedule available here .
HOW	Monthly electronic reports should be submitted via Euronext's <i>MyMarketData Portal</i> or alternatively via FTP in VRXML format.

2. MONTHLY REPORTS

This section provides more detailed information on how to fulfil your reporting obligation to Euronext as described in the EMDA Reporting Policy, which forms part of the EMDA

2.1 WEB PORTAL

When your organization enters into the EMDA and access to real-time market data commences:

- Euronext will set-up an account for you to allow you to report electronically. Log-in details will be provided to you by e-mail.
- Euronext will set-up the appropriate market data products and corresponding product codes under that account.

You will then be able to complete and submit electronic reports under an account set-up by Euronext. Please do not forget to confirm the details entered prior to submitting a report to Euronext.

2.2 DISPLAY USE OF REAL-TIME MARKET DATA

The EMDA Reporting Policy, which forms part of the EMDA sets out your reporting obligation for real-time market data access for the purpose of displaying such market data. Note, it excludes non-display use which must be licenced via the Order Form and therefore does not need to be reported. For more information about licensing your non-display use please refer to the clauses set out in the EMDA Use Policy.

2.3 MARKET DATA DISPLAY USE FEES

You will be charged for the right to display real-time market data. The fees outlined in the Information Product Fee Schedule are applicable per reportable unit (i.e. User per Source or Device, whichever is applicable) with the ability to access such [Euronext Market Data Product](#) (i.e. you will be charged based on your report). For the Information Product Fee Schedule please refer to our [Market Data Website](#).

Monthly market data display use fees are only waived where the use of real-time market data is for the sole purpose of monitoring and maintenance of your systems and/or development, marketing, training and/or demonstration of your devices and applications (i.e. your operational use), provided that:

- This use of real-time market data is solely in support of your real-time market data redistribution and not as part of any other commercial or other business functions and/or solely in support of your trading activities on Euronext markets and not as part of any other commercial other business functions; and
- That you report such operational use of real time market data to Euronext in accordance with the EMDA Use Policy and these reporting guidelines.

2.4 WHAT TO REPORT

You should report your own display use and/or your subscriber’s display use of real-time market data by completing and submitting a monthly electronic report. For this purpose, you should count and report the number of reportable units (Users per Source and/or Devices, whichever is applicable) with the ability to access real-time [Euronext Market Data Products](#) within a calendar month, per location/subscriber.

2.5 UNIT OF COUNT

For your organization’s own accesses, you should report the number of Users per Source with the ability to access real-time market data. ‘User’ refers to a natural person and ‘Source’ refers to each separate data feed product from an Information Supplier. Netting between different sources is not permitted. For more information about the User per Source unit of count please [click here](#). Where you cannot allocate a device or application to a natural person you should report the device or application. Note, simultaneous access on such device is not permitted. For your subscriber’s accesses to Information Supplier-Controlled market data you should report each Device. For your subscriber’s accesses to Recipient-Controlled market data you should report the information provided by such subscriber via a data feed access declaration.

2.6 WHEN TO REPORT

You have to complete and submit a monthly electronic report. Your initial report should be submitted within 15 days after the calendar month in which your organization’s access to real-time market data commences. Subsequently you should report each calendar month within 15 days after a reporting period. The table below uses the year 2021 as an example to illustrate the reporting deadlines. The same day and month will apply for the years following.

As a delay in your reporting can cause a disruption of Euronext’s standard processes, Euronext may charge for compensation if you do not submit your report before the reporting deadline. For more information we refer to clause 3.3 of the EMDA Reporting Policy.

2.7 HOW TO REPORT

You can report via Euronext's *MyMarketData Portal*. You can enter data into the *MyMarketData Portal* via the graphic user interface or via an excel file upload.

You can manually report for each Location through the *MyMarketData Portal* and/or report via an excel upload your:


- Internal distribution and use (including your operational use)
- Subscriber's access
- Sub vendor's access
- Subscriber's access that are approved to report natural user
- Provision of managed non-display services
- Provision of ASP services /ESP services to trading members
- Provision of White Label Services
- Non-professional subscribers
- Page views

3. EURONEXT'S MYMARKETDATA PORTAL

This section describes how to access Euronext's *MyMarketData Portal* and how the home page's functionalities work.


3.1 ACCESSING THE PORTAL

Euronext's *MyMarketData Portal* is available at <https://mymarketdata.euronext.com>. Your email address will be the UserID and once Euronext has set you up for reporting a link to create your own password will be sent to your email address.

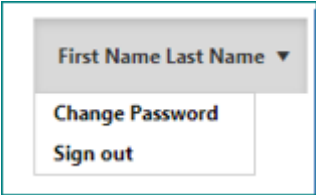

Here you will also find the '**Report Online**' button that gives access to the *Usage Reporting* page, and the dates and status the last time a report was successfully validated, the last month that has been reported, the last time a report was submitted, and the status of the last report.

4. USAGE REPORTING – MANUALLY

This section describes how to create your report via the graphic user interface in the *MyMarketData Portal*.

To go to the *Usage Reporting* page, click on '**Report Online**' button on the *Account* page. This will open the *Usage Reporting* page with the current reportable inventory of that account.

Note, you should report the number of reportable units with the ability to access a particular Euronext Market Data Product under a unique Location Account Number in accordance with clause 4 of the EMDA Reporting Policy.

4.1 CREATING A LOCATION

To create a new Location, you should use the '**Create Location**' button. This opens a pop up with three tabs.

In the '**Location**' tab, please fill in the fields as requested. Please note the red fields are mandatory.

- '**Location ID**' field: assign a unique identifier by which you can identify the Location.
- '**Name**' field: the name field should always be the statutory name of the applicable organizational entity (i.e. if the organizational entity's statutory name is 'ABCD Ltd.' Please include that in full and not just 'ABCD').

The Location details (i.e. name, address, city, etcetera) should be that of:

- your organization (internal distribution and use)
- your subscribers (subscriber access)
- your information suppliers or sub vendors (redistributor access)
- your members (the organizational entity of the Member's group, per country i.e. member access)

Once the Location you want to edit is displayed, you can then edit the relevant information on the relevant tabs (Location, Contact, Products) of the **'Edit Location'** pop up.

Please note that any edits need to be saved by clicking '**Save**' before they are applied. You cannot deselect products that are already present in the inventory and shown on the *Usage Reporting* page.

4.3 INACTIVATING A LOCATION

You can inactivate a Location via the '**Inactivate Location**' button on the *Usage Reporting* page.

Select the Location that you want to inactivate and click '**Inactivate Location**'. You will get the following pop up.

When you can click '**Yes**', the complete inventory (all products) of the Location will be set to zero in the actual month of reporting.

4.4 REPORTING THE USAGE

Once a Location has been created you can add inventory (number of reportable units) under said Location. On the *Usage Reporting* page, you see the current reportable inventory of Locations for an account.

For each Location you should report the total number of reportable units with the ability to access Euronext Market Data per Euronext Market Data Product during a calendar month.

On the Usage Reporting page, you can select per line for each Location per the relevant Euronext Market Data Product(s) and enter the total number for the calendar month. The *MyMarketData Portal* will prefill the number fields according to the last received and validated report. In this example we report the number for *August 2019*.

If you want to adjust the number of the Euronext Market Data Product for a Location, you can enter that straight in the number field of the calendar month itself.

The **'Reset'** button will reset the number you entered to the original value as reported for the Location and Product during your last report.

If you want to undo the changes of all the numbers that you have entered, you can use the **'Reset All'** button. You will get the following pop up.

You can click **'Yes'**, and all changes made will be undone to the number of Euronext Market Data Products of those Locations.

If you want to adjust the reported numbers of retro-active months, you can click the **'More months'** button and the retro-active months will be shown on the *Usage Reporting Page*.

4.5 SUBMITTING A REPORT

Before being able to submit a report, all lines on the *Usage Reporting* page must be accepted. You can accept single lines via the **'Accept'** button or use the **'Accept All'** button to accept all lines simultaneously.

APPENDIX 2: UNIT OF COUNTS

This appendix provides more detailed information about the different unit of counts.

A2.1. DEVICE

A device unit of count is applicable:

- When you (the information supplier) provide information supplier-controlled real-time market data to subscribers, either professional subscribers or non-professional subscribers, for the purpose of display. This means that the delivery mechanism does not allow the subscriber to control the type and number of users and/or devices that can access the market data and is thereby incapable of further dissemination of such data by such subscriber.
- When you (the information supplier) provide information supplier-controlled real-time market data to non-professional subscribers (i.e. private investors).
- For all your internal display use or your subscriber's display use of recipient-controlled real time market data on a device, which cannot be allocated to a single natural person.

A device means any terminal, Access ID or other method capable of accessing, receiving, processing, displaying and/or otherwise Using the Information including, but without limitation, any listening device or any other form of audio communication or similar equipment.

IMPORTANT: Simultaneous access on a device is not allowed. For example, in case of simultaneous access on a single device (incl. user id), each instance with access to real-time market data on that device (incl. user id) is to be counted and reported.

In accordance with the unit of count, device, you (or your subscriber, in case of recipient-controlled entitlement) should count how many devices have the ability to access market data for each separate data feed product from you (the information supplier). You should report this number to Euronext.

A2.2. USER PER SOURCE

A user per source unit of count is applicable:

- When you (the information supplier) provide recipient-controlled real-time market data to subscribers, professionals, for the purpose of display. This means that the delivery mechanism allows the subscriber to control the type and number of users and/or devices that can access the market data and is thereby capable of further dissemination of such data by such subscriber.
- In case of your internal distribution for the purpose of display use.

In accordance with the unit of count, User per Source, you (or your subscriber, in case of recipient-controlled entitlement) should count how many natural users have the ability to access market data for each separate data feed product from you (the information supplier). You should report this number to Euronext.

A2.3. EXAMPLE 'USER PER SOURCE' - WHEN YOU ARE AN INFORMATION SUPPLIER

The illustration below describes a situation in which you (the information supplier):

- are internally distributing and using real-time market data; and
- are redistributing real-time market data to a subscriber

In the example below you should report 1 user per source (for your internal access and use) and 1 device and 1 user per source (for your subscriber's access and use).

1. Jack Brown one of your employees has the ability to access your real-time market data products on two display devices. For such internal distribution and use of real-time market data the **'User per Source'** unit of count applies. Therefore, you should count and report to Euronext 1 user (Jack Brown). Note, even though Jack Brown has access to market data twice, he only has to be counted once, as both are fed from one source.
- The diagram illustrates two scenarios of market data access. 2. One of your applications has the ability to access real-time market data for the creation of derived data. For non-display use of real-time data, you have to be licensed separately via the Order Form.
 3. John Smith one of your subscriber's employees has the ability to access your real-time information supplier-controlled market data product on one display device. For the display of information supplier-controlled market data the **'Device'** unit of count applies. Therefore, you should count and report to Euronext 1 device (that of John Smith).
 4. John Smith also has the ability to access your real-time market data products on two display devices, but in this case through recipient-controlled entitlement. For the display of recipient-controlled market data the **'User per Source'** unit of count applies. In this case, the subscriber should count and report to you 1 user (John Smith). You then shall report this user to Euronext. Note, even though John Smith has access to market data twice, it only has to be counted once, as it comes from one source (your data feed product)
 5. Lastly, one of your subscriber's applications has the ability to access your real-time recipient-controlled market data product for non-display risk management. For non-display use the subscriber has to sign the EDSA agreement, if the subscriber is not already part of the EMDA agreement yet. It is your responsibility to ensure that all of your subscribers that are in receipt of recipient-controlled information from you have entered into an agreement with Euronext (whether they have non-display use or not).

A2.4. EXAMPLE 'USER PER SOURCE' - WHEN YOU ARE A TRADING MEMBER

The (simplified) illustration of market data access through market connectivity services is meant to provide more clarity on how to count and report the number of users with the ability to access Euronext market data.

In accordance with the unit of count, **User per Source**, you should count how many natural users have the ability to access market data for each market connectivity service (provider) and report the aggregate number per country.

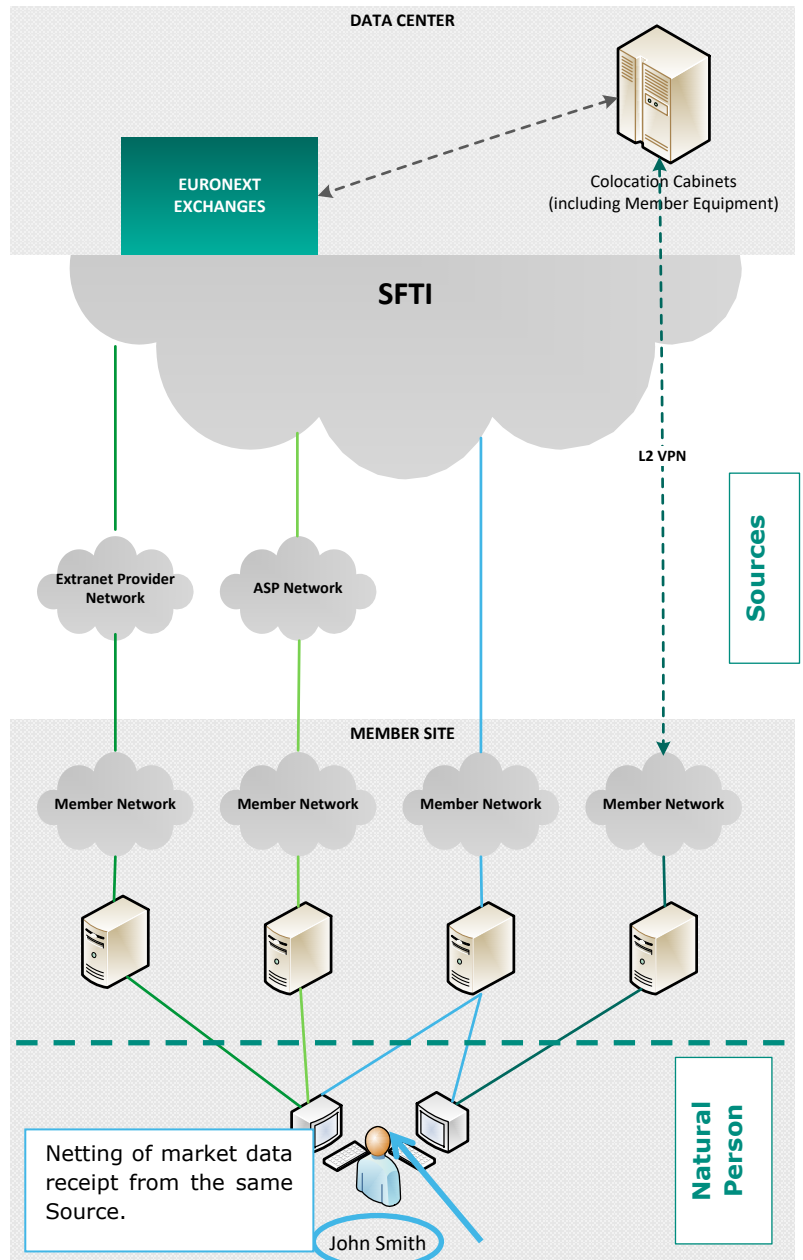
In the illustration John Smith is a user at a member firm and this user has two terminals:

- On one terminal John Smith has access to market data as part of three market connectivity services or 'Sources' (Extranet Service Provider service, Application Service Provider service, SFTI Direct Connection).
- On one terminal John Smith has access to market data as part of two market connectivity services or 'Sources' (SFTI Direct Connection, Colocation Cabinet).

In this case, the member firm should count and report John Smith four times (i.e. under four main locations). Once for the extranet service provider, once for application service provider, once for the SFTI Direct Connection and once for the SFTI Co-Location.

Note, even though John Smith has access to market data from the SFTI Direct Connection twice, it only has to be counted once, as it comes from one source.

APPENDIX 5: APPENDIX 5: ADDITIONAL EXPLANATION REGARDING THE EMDA POLICY

Reporting your Internal Use of Information

Clause 4.2: When you are a member receiving real time data from Direct Access and/or an ASP/ESP service, you will need to report your internal use (trading activities) **directly** to Euronext via the -IU product codes.

But if you are also receiving data from a redistributor (information supplier) you will need to report this usage to the redistributor (indirectly).

Except if you are not approved as Natural User, then you do not need to report your real time data received by your vendor service **directly** to Euronext. For further reference, the reporting is described in the Natural User Application Guidelines.

Reporting Subscribers Approved to report Natural User

If the subscribers are approved to report Natural user, then you (as a redistributor) as Information Supplier of the Information, should report the provision of these subscribers via the -SDB or -DDB product codes. These -SDB and -DDB product codes are non-billable, 0 (zero) Euro, so the subscribers will not be billed twice.
