

# DATA SOLUTIONS

Euronext is pleased to inform clients that its file-based data products currently accessible via <a href="ftp.data.euronext.com">ftp.data.euronext.com</a> (also known as NDM) will be migrated to a new delivery platform – dubbed the Data Shop – and that the delivery of the files/products via the legacy NDM server will stop.

The aim in introducing the Data Shop platform is to improve the overall user experience and information security by offering the files through the SFTP protocol.

The migration of the files included in the different Euronext data products is planned as follows

## **ACTIONS REQUIRED**

## Phase 1

Clients are required to test the connectivity to the new sftp server by downloading a dummy file.

## Phases 2, 3 and 4

Clients are required to adjust their processes/systems to start accessing the files/data products on the Data Shop platform.

The files/data products will be provided in parallel on the Data Shop platform and the legacy NDM server (see table above). At the end of date of each phase, the delivery of the files/data products in scope of that phase on the legacy NDM server is planned to stop (e.g the delivery of the historical data files on the legacy NDM server is planned to stop by Mid-March 2023).

#### **NEXT STEPS**

Euronext plans to provide clients with further instructions in January 2023 and updates on a regular basis thereafter.
