Further to previous <u>announcements</u>, Euronext reminds clients regarding the migration of its filebased data products currently accessible via <u>ftp.data.euronext.com</u> (also known as NDM) and email onto the new delivery platform – dubbed the Data Shop.

IMMEDIATE ACTION REQUIRED:

It is matter of urgency to anyone that did not yet migrate to the Data Shop to act immediately to avoid any disruption in accessing our file - based data products.

If you have already successfully migrated, please ignore this reminder.

REMINDER

• **Phase 4** – the delivery of the files* in scope of this phase on the legacy server (<u>ftp.data.euronext.com</u>) is scheduled **to stop on 30 June 2023.**

ACTIONS REQUIRED

Phases 1, 2, 3.1 and 3.2

These phases have been completed. No further actions are required.

Phase 4

Clients subscribed to Corporate Actions products and the Master File products are required to adjust their processes/systems to start accessing the files/data products in scope of this phase on the Data Shop platform before 01 July 2023.

To ensure a smooth transition, Euronext will deliver the files on the Data Shop platform and the legacy server (<u>ftp.data.euronext.com</u>) in parallel. The delivery of the files in scope of this phase on the legacy server is planned to stop on 30 June 2023.
