

EURONEXT ANNOUNCES CHANGES TO ITS POLICIES AND FEES FOR MARKET DATA, EFFECTIVE 1 JUNE 2022

Note, this is a standard announcement to all customers for information purposes only. Euronext is required to notify its customers in advance of any changes to the Euronext Market Data Agreement, including as a result of policy and fee changes.

Euronext announces changes to its market data agreement, effective 1 June 2022. The key changes are as follows:

Data Migration to Aruba

Euronext will migrate its primary Data Centre and related Colocation services from Basildon, UK, to the Aruba Global Cloud Data Centre IT3 in Bergamo, Italy, on the 6th of June 2022. Euronext will operate a state-of-the-art Colocation facility available to members and non-members. The Aruba Data Centre meets the highest quality standards (Rating 4 certification), provides the maximum level of safety and resilience, and is 100% powered by renewable energy, enabling Euronext to minimise its environmental impact.
