GENERAL

This Information Product Fee Schedule describes the Information Products marketed by Euronext and the corresponding Fees. It forms an integral part of the agreement between the Contracting Party and Euronext, as well as the Euronext Subscriber Terms and Conditions, that refer to this Information Product Fee Schedule. All capitalised terms used, but not defined herein have the same meaning as defined in that agreement or Euronext Subscriber Terms and Conditions.

The Fee model applicable to Information Products distinguishes by scope and scale of Use of the Information. Where scope and scale are distinguished by Use type, Customer category and Unit of Count.

All Fees stated in this Information Product Fee Schedule are in Euro, excluding sales tax (VAT) and applicable per month. If not stated otherwise in this Information Product Fee Schedule, Fees are to be paid on a cumulative basis.

The available Information Products are described in the following table:
