EXECUTIVE SUMMARY

Customers are invited to test the Euronext Optiq[®] Phase 3: Order Entry Gateway (OEG) and Matching Engine (ME) on All Derivative Market Segments during the Dress Rehearsal organised in the Production environment on Saturday 19 October 2019 between 11:00 and 16:00 Central European Summer Time (CEST).

This Dress Rehearsal will allow customers to test the target Production implementation of Order Entry Gateway (OEG) Derivative in advance. Customers will not be authorised to take part in the Dress Rehearsal week-end unless they have (i) validated their conformance test, (ii) confirmed Telnet connectivity to Production and (iii) ordered their Order Entry (OE) Sessions for Production.

Markets will close on the evening of Friday 18 October 2019 and open on Monday 21 October 2019 as usual, without taking the activity of Saturday 19 October 2019 into account. Customers are responsible for purging all market data and order entry data sent and received during any Saturday test.

1. SCOPE OF THE TEST

1.1 TEST OVERVIEW

Customers are expected to conduct the following tests:

- Secure network resources on the day of the Dress Rehearsal to validate firewall / security path
- Connect to the Production environment
- Inject orders
- Purge the book at the end of the day and restore the order book to Friday night

Validate their participation at the end of the day through the following web form.

1.2 ACCESS TO SERVICES & APPLICATIONS

Euronext services and applications will be set up as follows for the rehearsal:

• Optiq Order Entry and MDG Phase 3 for All Derivative Market Segments, including Drop Copy

1.3 DETAILS

Below please find details relevant to the Optiq Derivative Order Entry (OEG) and Matching Engine (ME) Dress Rehearsal tests for Derivative Segments on Saturday 19 October 2019.

Between 11:00 and 16:00 CEST, customers are required to:

- Connect to the Production environment:
 - □ Test and validate the new Optiq Order Entry logical connectivity on Derivative market segments.
 - □ Log on through their OEG connections for Derivatives:
 - OEG connectivity for: Equity Derivatives, Financial Derivatives, Index Derivatives, Commodities segments
 - Retrieve required files from Euronext Files Services (EFS).
 - □ Perform Market Data checks on MDG Phase 3 (all Derivative segments).
 - Check the market data broadcast via multicast by connecting their application/feed handler to Real time and Snapshot.
- Inject orders
 - □ For example: Any Derivative segment order through OEG.
 - □ Customers can verify the publication of market data through the expected MDG channels.
- Purge the book at the end of the day and restore the order book to Friday night
 - □ This applies to orders sent through OEG for any Derivative segment and any internal data stored on the client side.
- Validate their participation at the end of the day via the web form:
 - □ The <u>Dress Rehearsal Participation Form</u>

Between 16:00 and 18.00 CEST, Euronext may conduct further internal tests. Customers are invited to ignore any data received after the Dress Rehearsal tests.

- Tests with LCH
- Functional High Availability
- Cash markets
- Saturn

MAIN PRINCIPLES OF THE TEST 3.

Customers will be notified to connect to the platform via the Market Status webpage.

Upon confirmation of start of tests customers should be able to connect to the Euronext OEGs and MDGs for the market segments below:

- **Equity Derivatives**
- Index Derivatives
- **Financial Derivatives**
- Commodities

The sequence for market opening is the following:

- Euronext will switch to the Call trading phase
- As soon as Euronext considers that Derivative markets are ready to be fully operational, a continuous trading session will be set up on Optiq. Customers are invited to make sure that their internal systems and access means are correctly synchronised with Euronext Optiq.

Euronext would like to make this test as realistic as possible in order to draw the most relevant and useful conclusions, and therefore encourages customers to participate actively by sending orders.

3.1 **TRADING DATES DETAILS**

The trading date used for the purposes of the test will be Saturday 19 October 2019.

For all Derivative segments: No orders will be present in the book

Euronext invites customers to enter orders as they would do in the Production environment.

MDG Standing data files for Derivative markets will be made available on Saturday 19 October 2019 with the business date of Monday 21 October 2019. Please make sure you do not have any security in place that would prevent to process them.

During the rehearsal on 19 October 2019 HA tests would not be performed.

3.2 PRE-REQUISITES FOR TAKING PART IN THE DRESS REHEARSAL

It is mandatory for any customer expected to take part in the Dress Rehearsal week-end

- 1) To have validated their conformance test,
- 2) To have confirmed Telnet connectivity to Production and
- 3) To have ordered their OE Sessions for Production.

4.1 IMPORTANT REMINDERS

During the test, Euronext will <u>not</u> be able to broadcast the real-time Derivatives Standing data messages over Optiq Market Data twice. Customers who have missed the broadcast of the referential data are requested to use the Optiq Derivatives Standing Data files made available on the <u>EFS</u>.

Euronext will not consider any requests or potential customer issues encountered on the day of the Production migration if the customer has not taken part in the prior rehearsal tests or completed EUA validation.

4.2 ROLL-BACK FOR CUSTOMERS' INTERNAL SYSTEMS

Order Books

Upon completion of the Dress Rehearsal, customers must restore/rollback the order book data in their internal Production systems to the state of Friday 18 October 2019 evening after the end of the trading session. It is very important that customers do NOT synchronise their order book with the data from the **tests** performed on Saturday 19 October 2019.

The Saturday 19 October 2019 session will not be taken into account in the Live/Production environment which will start on Monday 21 October 2019 as usual. Customers are requested to ensure their readiness for the next trading day's activities following any Saturday test.

Customers are responsible for purging all market data and order entry data sent and received during any Saturday test.

Standing Data:

Optiq Step 3 Derivatives Standing Data Files will be provided on the Euronext File Server (EFS) for Equity Derivatives, Index Derivatives, Financial Derivatives and Commodities segments.

These files provided for the rehearsal will have the date of Monday, and will override the files that were generated EOD Friday. After 18:00 on Saturday, standing data files will be rolled-back to the content to use for trading on Monday.

Customers are responsible for making sure that they incorporate the correct standing data for trading on Monday.
