1. TELNET CONNECTIVITY TESTS

Telnet connectivity testing for the Order Entry Gateway (OEG) is a part of the overall testing for Optiq Phase 3 Derivatives. This step is a pre-requisite for participating in Dress Rehearsal weekends. The purpose of this test is to perform a telnet to validate the route from the customer's IP address(es) to Euronext Derivatives Markets' Optiq OEGs in each environment.

The IP addresses and ports for the OEG connectivity telnet tests are provided in the table below.

Important: The table below indicates the IP addresses. However, clients are strongly advised to obtain the IP addresses of each partition provided in the standing data file on a daily basis.

As a reminder, standing data files are made available on a daily basis via the Euronext File Service (EFS).

1.1 IP ADDRESSES FOR CONNECTIVITY TESTING SETUP ON EURONEXT DERIVATIVES MARKETS

External User Acceptance (EUA) environments

Customers will be provided the details of their Logical Access for the Next and Current EUA, two weeks prior to opening of these environments to client testing of Optiq.

Each Logical access has a port dedicated to the submission of the order entry messages.

IP addresses for these environments can be found in the *Euronext Markets – Optiq OEG Connectivity Specifications* document.

If customers wish to perform telnet connectivity tests in the EUA environments, the port dedicated to such tests is: 30000

Production and Disaster Recovery (DR) environments

The table below provides the overall list of IP addresses, and ports dedicated for testing, for the Production and Disaster Recovery (DR) environments. This connectivity information will be in use for telnet tests for the Euronext Derivatives Markets on the Optiq platform.

The table provides the time period during which these telnet tests may be conducted by clients.

The table provides times in CEST. From 27 October, the below times will remain unchanged but will be expressed in CET (Central European Time).
