1. INTRODUCTION

1.1 PURPOSE

MiFIR Art. 26(5) requires the obligation for a trading venue to report complete and accurate details of the transactions executed on its systems to their National Competent Authority, when they involve a firm that is not directly subject to MiFIR/MiFID II rules (the “Non-MiFID Member Firms”) in MiFIR Art. 26(1).

This document provides indications to the Non-MiFID Member Firms of Euronext Cash & Derivatives markets, in order to fulfil the obligation to article 2.4 MEMBERS CONTINUING OBLIGATIONS, rule 2402, in the Euronext Rule Book Book I: Harmonised Rules.

Non-MiFID Member Firms must ensure at all times that it has provides Euronext with all the data required according to the Commission Delegated Regulation (590/2017/EU) under conditions and manner specified by Euronext in one or more Notices.

This document is relevant to trading, operations, compliance and technical staff within the Non-MiFID Member Firms.

2. OPERATIONAL PROCESS

2.1 OVERVIEW

In order to fulfil to the requirements of MiFIR Art. 26(5), Euronext is reporting transactions made on Euronext Cash & Derivatives markets on behalf of non-MiFID members. Due to the level of information required it is not feasible to collect all data required from the order entry. As such, all Non-MiFID Members must provide Euronext with all the complementary data requested under RTS 22, to allow Euronext to report complete and accurate details of transactions executed on its markets to the Competent Authorities. For this purpose, client can amend transactions editing the fields where client input is expected (details below in this document).

Non-MiFID members Transaction Reporting is executed via Euronext Saturn application, through which transaction reports are built, validated, and forwarded to the NCA.

Saturn opening hours: 06:30 – 22:00 CET weekdays.

Transaction(s) on Euronext markets are sent to Saturn. Saturn then performs internal reconciliation, validation against XSD, and checking for content errors. This is an automatic process. A transaction will be reported once all checks have been passed.

Members must ensure all transaction details are correct and ensure to provide Euronext with all relevant information so that complete and accurate transaction reports can be submitted for each trade.

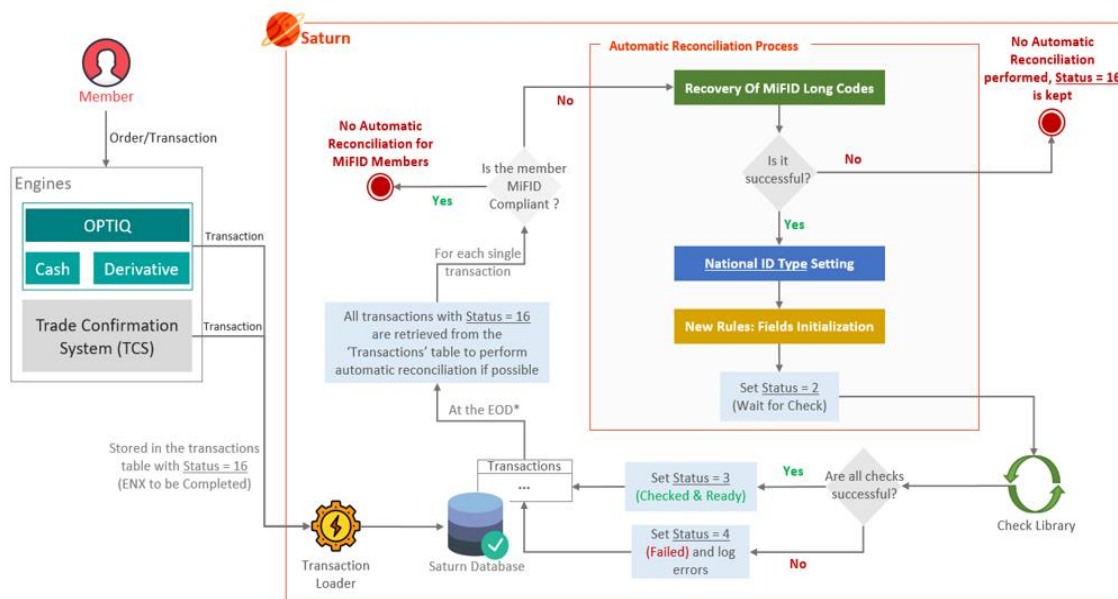

* All trading members on Euronext markets must submit their Short Long Code mapping in Saturn SLC Manager, at least, the day before they use the short code in Production.

** The Automatic Reconciliation currently runs twice per day (13:00 and 21:30) but will be extended to run once every hour with the migration of Borsa Italiana Non-MiFID clients to Saturn.

2.2 AUTOMATIC RECONCILIATION

The below chart shows how Saturn receives and processed transaction reporting for non-MiFID members. The process is automatic.



3. TRANSACTION REPORTING GUIDELINES

3.1 ACCESS

All Non-MiFID members have by default access to Saturn.

To have the correct Non-MiFID Transaction Reporting rights, the user must be:

- Category: **Supervisor**
- Profile: **ArmNonMifid** (profile already available by default on Saturn, both in Production and Next-EUA environment)

If the Member needs to request a new user:

- In case of GUI user, the MCA (Member Connectivity Administrator) can request it via Connect Portal webform: <https://connect2.euronext.com/en/form/saturn-user-id-order-form>
- In case of API user, the Saturn Admin user is able to create it, as per paragraph 3.5.3 of the [Saturn - User Guide - Euronext Cash and Derivatives Markets - External - v5.28.0](#)

As soon as it is created, the Saturn Admin can assign to the user the aforementioned Category (**Supervisor**) and Profile (**ArmNonMifid**). The same Category and Profile assignment can be done for an already existing Saturn user.

Customers can contact Market Access team (market-access@euronext.com) for support on configuration process.

IMPORTANT:

Prior to accessing Saturn for PRODUCTION Transaction Reporting amendment purposes, all Non-MiFID members must perform tests to amend transaction(s) in our Next EUA (p-EUA) environment and test the login in Production Environment. While there is no mandatory conformance test, clients must ensure to be able to perform amendments and to not cause any issues on the transaction reporting.

Customers can contact Operational Client Support Desk (see section 1.3) for support on testing process.

3.2 STATUS REPORT E-MAIL

All Non-MiFID members are asked to sign-up to receive a daily report with status of their transactions inside Saturn.

Please read the latest *Saturn - User Guide - Euronext Cash and Derivatives Markets - External* document located on [IT Documentation](#). Refer to section "3.8 E-MAILS NOTIFICATION" and case (1).

3.3 AMENDMENTS

As explained in previous sections, Euronext reports on behalf of Non-MiFID members firms with RTS22 data available in an automatic manner.

Non-MiFID member firms are expected review and amend transactions whenever additional information is required or requires to be amended.

The **Amendment** of transactions can be performed using **File Upload** function (via Saturn GUI or API). There is no possibility to "Enter" or "Delete" Euronext transactions.

The only exception is the reporting of disaggregated trades (linked to pending allocation and aggregated transactions). Refer to the section 3.4 for more details.

Please refer to the [Saturn Web Specifications](#) for technical details on how the amendment of transactions works and the file upload details.

Non-MiFID members should not amend transactions before the Automatic Reconciliation has run (when in "ENX to be Completed" status). This can interrupt the automatic process and cause transactions to remain in a "Failed" status. Likewise, clients should not amend fields that are automatically populated by the Automatic Reconciliation unless specified. Refer to the table in section 3.5 for list of fields where client input could be expected.

As a reminder, transactions can only be amended when in status:

- **Accepted**
- **Checked & Ready**
- **Failed**
- **Rejected**

A transaction in "**Failed**" status should be corrected by the Non-MiFID member.

A transaction in "**Rejected**" status will be investigated by Euronext as it's likely not related to the content of the file.

The below table shows fields where client input is expected. Other fields that are automatically populated by Saturn are not expected to be amended by clients.

IMPORTANT

Although considered as amendable in the previous version of the document, the fields related to the Buyer and Seller information (Buyer/Seller Country Branch, Buyer/Seller Decision Maker Code, Buyer/Seller Decision Maker First Name, Buyer/Seller Decision Maker Surname, Buyer/Seller Decision Maker BirthDate) must not be amended. If a Non-MiFID member needs to amend one of the field related to the Buyer/Seller information, can refer to Euronext Operational Client Support Desk.

3.3.1 FILE UPLOAD (.CSV)

The amendment can be performed using the file upload function (.csv format), only after the Automatic Reconciliation has run.

A subset of fields are mandatory in the file upload. The value of those fields must match the details of the trade to be amended.

The fields are:

- **ARM APA Indicator** – should always be “1” Transaction Reporting
- **Side** – “1” (Buy), “2” (Sell), or “3” (Cross)
- **Action** – always “2” for Amend
- **Transaction Reference Number** – The Transaction Reference Number generated by Saturn (after the Automatic Reconciliation has run).
- **Trading Venue Transaction ID** – The Trade Unique Identifier of the trade
- **Executing Entity ID** – Non-MiFID member LEI
- **Trading Date Time** – The Trading Date Time of the trade
- **Venue** – MIC of the instrument
- **Security ID** – The instrument ISIN code.

Additional fields should be added depending on what information should be amended. Therefore, to the aforementioned mandatory fields, customer needs to add any fields to be amended (list provided in the previous section).

Besides the mandatory fields, fields that do not require an amendment should not be present in the .csv file. Uploading a header with no data will count as a removal.

Note that some fields cannot or should not be amended. Refer to the previous section and to the paragraph 3.5 - *Key Fields for consideration* for further details. Only a subset of fields are expected to be amended by clients.

In the example, the Short Selling Indicator field has been modified, indeed the file includes the mandatory fields and the Short Selling Indicator field.

3.4 REPORTING OF DISAGGREGATED TRADES

Non-MiFID members are reminded that, in case of TRs referring to a transaction derived from an order with ClientIdentificationShortCode flagged as 'AGGR' or 'PNAL' at order entry, the member is requested to report the off-venue disaggregated transactions to Euronext (see section 5.30.3 in *ESMA guidelines on Transaction Reporting*).

This is the only case where a Non-MiFID member should Enter a new transaction, and it can only be performed through the **File Upload** function (Saturn GUI or by API).

In these cases, the following rules must be applied:

- a. In the Transaction Reporting for the aggregated market-side transaction:**

when the Non-MiFID Member Firm is buying (selling) under "AOTC" trading capacity:

- The **"Buyer(Seller) Identification Code"** must be always populated with value **"INTC"**;
 - The **"Short Selling Indicator"** must always be reported as blank.
- b. In the Transaction Reporting for the disaggregated client transaction:**
- The field **"Venue"** must be always set to **"XOFF"**;
 - The field **"Trade Unique Identifier"** must contain the aggregate market-side Transaction Unique Identifier, with a unique sequence number;
 - The field **"Disaggregated Trade Indicator"** must be always set to **"1"**.

The fields **"Trade Unique Identifier"** and **"Disaggregated Trade Indicator"** are mandatory for the disaggregated client transaction reporting.

As far as concerns the **"Trade Unique Identifier"** field, specifically used for the disaggregated trades:

- When reporting a disaggregated trade, **Trade Unique Identifier** must be populated with the *TUI+Seq num* and the field **Trading Venue Transaction ID** should not be reported (not present in the .csv file).
- Instead, when amending a trade not related to a disaggregated transaction, the **Trading Venue Transaction ID** field must be populated with the TUI.

Furthermore:

- When entering a disaggregated transaction, all relevant RTS22 fields must be reported in the disaggregated transaction report, including Long codes (Saturn does not reconcile disaggregated transactions versus Saturn Short Long Code mappings). This is different from making an amendment, where only a subset of fields are required in the file upload.
- A reconciliation between the original and disaggregated trade will take place and a reconciliation error may appear if the information does not match.

More details can be found in the *Euronext APA ARM services – Functional overview* document, see section "5.4.1 Pending allocation and aggregated transactions reporting".
